#### **Main Motions**

New Business:

#### A. Donation for Droverthon

- A. Scholarship for Working Students

  - iv. Q Buster: Would every student essentially have this scholarship?

  - vii. A Ozee: Yes, but the time it takes to con the system indicates that financial need is needed.
  - viii. Q Payne: Would you be open to an amendment that gives different amounts of money to students who work part-time and full-time?
  - ix. A Ozee: Yes.
  - x. Q Buster: Since it is difficult to lose this scholarship, it could be a financial strain on the university and make it more difficult to pass the resolution?

- xi. A Ozee: It could but if we start high with our demands this can result in a preferable outcome.
- xii. Amendment from Payne: Student who work full time (40+ hrs a week) would be allotted a higher scholarship amount than students who work part time (12 hrs a week).
